This purchase order is issued in regularization of this office letter of intent Dt:28.03.2014 and your acceptance mail Dt:23.04.2014.

**2) SCOPE OF SUPPLY:**

This contract relates to the Supply of "Boiler Circulating Pump without pump casing of M/s.Torshima Pump MFG Co. Limited, OSAKA/JAPAN make for Unit-XI (1X500MW) of KTPS-VI Stage as per schedule of material, as detailed in clause No.(3) below.

**3) SCHEDULE OF MATERIALS AND PRICES:**

**4) PRICE BASIS:**

The prices accepted in Clause No.(3) above, are FOB OSAKA/KOBE, JAPAN basis. The total value of the contract is payable in JPY. The above prices are firm till the completion of supply and inclusive of Packing & Forwarding charges, but exclusive of Freight & Transit Insurance charges, Custom Duty, Inland Freight and Insurance Charges & Service Tax thereon.

**5. PACKING, FORWARDING:**

The prices accepted in Clause No.(3) above are inclusive of Special Export Packing and forwarding charges.

**8. IMPORT LICENSE: -**

As per the revised import/export policy in force, imports of raw materials and spare parts, equipments etc. barring items in the negative list can be freely made without necessity of an import license by purchasing necessary foreign exchange from open market.

- (c) Arranging settlement of any claims, during Guarantee Period.
- (d) Submission of PBG etc.
