These petitions came up for hearing on 03.01.2022 in the presence of Sri S. Rama Krishna, Managing Director for petitioner in all O.Ps., having been heard and having stood over for consideration to this day, the Commission passed the following:

COMMON ORDER

The Co-operative Electric Supply Society Limited, Sircilla (petitioner) has filed the above petitions for determination of Aggregate Revenue Requirement (ARR) and Expected Revenue from Charges (ERC) for FYs 2019-20, 2020-21 and 2021-22 respectively. The petitioner has sought the following prayer in the respective petitions:

O.P.No.1 of 2019:

"To determine the filing of ARR and ERC for FY 2020-21."

O.P.No.1 of 2020:

"To determine the filing of ARR and ERC for FY 2019-20."

O.P.No.1 of 2021:

"To determine the filing of ARR and ERC for FY 2021-22."

- 2. The Commission notices that as there are no filings for retail supply tariff for FYs 2019-20, 2020-21 and 2021-22 by the licensees in the Telangana State, there is no determination of bulk supply tariff for FYs 2019-20, 2020-21 and 2021-22 for the power being procured by the petitioner from the licensee viz., TSNPDCL.
- 3. The filings made by the petitioner for determination of ARR and ERC for FYs 2019-20, 2020-21 and 2021-22 have been taken up for hearing on the above said

date. At the time of hearing, the representative of the petitioner reiterated the prayer made in all the petitions. The Commission has examined the petition and the submissions made by the representative.

- 4. The Commission having heard the submissions of the representative of the petitioner, is of the view that the same cannot be proceeded with, in the absence of determination of retail supply tariff for FYs 2019-20, 2020-21 and 2021-22 of the licensees. In this regard, it may be appropriate to notice the order passed by the Commission in O.P.(SR) Nos.14 and 15 of 2021 in respect of filings of the licensees for ARR and retail supply business for FYs 2019-20, 2020-21 and 2021-22.
 - "5. As the licensees have not filed the proposals along with FPT within the stipulated period as specified in the Regulation No.4 of 2005, as there is less than 120 days in filing them for consideration. The Commission is unable to proceed with the filings in the present form on account of noncompliance of Regulation.
 - 6. In these circumstances, the Commission deems it appropriate to decline from entertaining the ARR Petitions mainly for the reason that the time period for which they were sought was already lapsed. Hence, they are refused."
- 5. Considering the discussion above and the factual matrix available insofar as retail supply tariff for FYs 2019-20, 2020-21 and 2021-22 is concerned, the present petitions cannot be proceeded with. Accordingly, the same stand rejected.
