This petition coming up for hearing on 20.04.2015 and 25.06.2015 in the presence of Sri. J. Ashwini Kumar, Advocate on behalf of Sri Y. Rama Rao, Standing Counsel for the Respondents 1 and 3, there being no representation on behalf of the petitioners on both the days, the Commission passed the following:

ORDER

This petition is filed under Sections 61 (h) and 86 (1) (e) of the Electricity Act, 2003 read with clauses 5.12.1 and 5.12.2 of National Electricity Policy and Clause 6.4 of National Tariff Policy seeking the following prayer in the petition.

"To provide concessional wheeling and transmission charges to the petitioners for captive use or 3rd party sale of wind energy to be in kind at 5% of energy delivered into the grid (which includes transmission and distribution losses) irrespective of entry and exit points and also voltage levels.

Therefore, we pray the Hon'ble Commission for concessional wheeling and transmission charges for wind power projects located within the State of Andhra Pradesh, in the present territory or in new states".

2. The petition was taken on file of the Commission under the above said OP No. upon implementation of the AP Reorganisation Act, 2014 and consequential establishment of this Commission. The petition was listed for hearing on three occasions namely 04.02.2015, 20.04.2015 and 25.06.2015. There was no representation on behalf of the petitioner on the last two occasions, therefore, it is deemed that the petitioners are not inclined to prosecute the petition filed by them.

3. Accordingly, the present petition is dismissed for default for non appearance of the petitioners. Any interim applications pending as such also stand dismissed for the same reason.
