PUBLIC NOTICE

O. P. No. 12 of 2017

In the matter of issuance of license afresh or the transmission activity in the state of Telangana to M/s. Transmission Corporation of Telangana in place of license issued by the erstwhile APERC in No. 1 of 2014 dated 11.07.2014 consequent formation of the state Telangana under sec 3 pf Andhra Pradesh Reorganisation Act, 2014 (Central Act, 6 of 2014)

Whereas the erstwhile Andhra Pradesh Electricity Regulatory Commission (APERC) had granted license (License No. 1 of 2000) on 31.01.2000 under Section 15 of the Andhra Pradesh Electricity Reform Act, 1998 (state Act No. 30 of 1998) to the then Transmission Corporation of Andhra Pradesh Limited (APTRANSCO), a company incorporated under the Companies Act, 1956 and having registered office at 2nd Floor, Vidyut Soudha, Khairatabad, Hyderabad for carrying on the business of transmission and bulk supply of electricity within the then state of Andhra Pradesh for a period of 30 years.

And whereas, the Government of India enacted the Andhra Pradesh Reorganisation Act, 2014 (Central Act No. 6 of 2014) carving out two new states of Telangana and Andhra Pradesh. Consequent thereto and after the State of Telangana coming into being as such, a new company by the name Transmission Corporation of Telangana has incorporated on 29.05.2014. Thereafter the assets and liabilities of APTRANSCO were bifurcated and transferred by an order of the then Government of Andhra Pradesh in respect of areas falling in the present state Telangana. The area of operation has been extended to whole of the state of Telangana.

And whereas, the TSTRANSCO has proposed and sought issuing of fresh license on the following two aspects.

"i) Consider the TSTRANSCO'S request to grant fresh transmission license in

lieu of the existing licence No. 1 of 2014, duly considering the following

changes:

ii) The name of the Transmission Licensee as "Transmission Corporation of

Telangana Limited (TSTRANSCO)", applicable for the entire State of

Telangana."

As the state has been newly established and the TSTRANSCO has been newly

created the licensee has to be issued by this Commission alone.

The application along with enclosures and the existing licence are available at

the corporate office of TSTRANSCO as well as the offices of the Superintending

Engineer of the transmission lines and substations located in the various parts of the

of the state of Telangana. The application and all other documents can be inspected

during office hours and if required obtain copies of the same from the above said

offices on payment of reasonable charges not exceeding photocopying charges.

The Commission desires that all the stakeholders, interested persons and

others in the matter and public at large may offer their comments, objections and

suggestions on the proposal of TSTRANSCO. The comments, objections and

suggestions shall be filed in the form prescribed in Regulation No. 2 of 2015 being

Conduct of Business Regulation available on the website of the Commission at

www.tserc.gov.in. The comments, objections and suggestions shall be filed in 6

copies addressed to the Secretary on or before **11.07.2017**.

The Comments and suggestions may be filed either in writing addressed to the

Secretary TSERC at the above address or sent by email to secy@tserc.gov.in.

However, in the event of mailing the objections, the same shall be sent in 3 copies as

post copy confirmation. The comments, objections and suggestions should be filed

before the Commission on or before 5.00 PM on 11.07.2017 with a copy of such

comments served to TSTRANSCO for its response.
