Chapter1 - Organisational Setup & Administration

1.1. The Commission

In exercise of the powers conferred under schedule XII (c) (3) of AP Reorganization Act, 2014, and in pursuance of Section 92 of A.P. Reorganisation Act, 2014, read with section 82 of the Electricity Act, Government of Telangana has constituted Telangana State Electricity Regulatory Commission, which came into existence on 03.11.2014. Further, Government of Telangana vide G.O.Ms.No. 13 Dated 22.10.2014 have appointed

- Sri. Ismail Ali Khan as Chairman,
- Sri. H.Srinivasulu, as Member (Finance) and
- Sri. L. Manohar Reddy as Member (Technical) Retired in August 2016

1.2. Functions of the Commission:

- The State Commission shall discharge the following functions under Section 86(1) of the Act, namely: -
 - (a) determine the tariff for generation, supply, transmission and wheeling of electricity, wholesale, bulk or retail, as the case may be, within the State:

Providing that where open access has been permitted to a category of consumers under section 42, the State Commission shall determine only the wheeling charges and surcharge thereon, if any, for the said category of consumers;

- (b) regulate electricity purchase and procurement process of distribution licensees including the price at which electricity shall be procured from the generating companies or licensees or from other sources through agreements for purchase of power for distribution and supply within the State;
- (c) facilitate intra-state transmission and wheeling of electricity;
- (d) issue licences to persons seeking to act as transmission licensees, distribution licensees and electricity traders with respect to their operations within the State;
- (e) promote co-generation and generation of electricity from renewable sources of energy by providing suitable measures for connectivity with the grid and sale of electricity to any person, and also specify, for purchase of electricity from such

sources, a percentage of the total consumption of electricity in the area of a distribution licence;

- (f) adjudicate upon the disputes between the licensees, and generating companies and to refer any dispute for arbitration;
- (g) levy fee for the purposes of this Act;
- (h) specify State Grid Code consistent with the Grid Code specified under clause(h) of sub-section (1) of section 79;
- (i) specify or enforce standards with respect to quality, continuity and reliability of service by licensees;
- (j) fix the trading margin in the intra-State trading of electricity, if considered, necessary; and
- (k) discharge such other functions as may be assigned to it under this Act.
- The State Commission shall advise the State Government on all or any of the following matters under section 86(2) of the Act, namely : -
 - (a) promotion of competition, efficiency and economy in activities of the electricity industry;
 - (b) promotion of investment in electricity industry;
 - (c) reorganization and restructuring of electricity industry in the State;
 - (d) matters concerning generation, transmission, distribution and trading of electricity or any other matter referred to the State Commission by that Government.
- As per section 86 (3) of the Act, the State Commission shall ensure transparency while exercising its powers and discharging its functions.
- As per section 86 (4) of the Act, in discharge of its functions the State Commission shall be guided by the National Electricity Policy, National Electricity Plan and tariff policy published under subsection (2) of section 3.

1.3. Powers of the Commission:

- The State Commission shall, for the purposes of any inquiry or proceedings under Electricity Act, have the same powers as are vested in a civil court under the Code of Civil Procedure, 1908 (5 of 1908) in respect of the following matters, namely:
 - i. summoning and enforcing the attendance of any person and examining him on oath;

- ii. discovery and production of any document or other material object producible as evidence;
- iii. receiving evidence on affidavits;
- iv. requisitioning of any public record;
- v. issuing commission for the examination of witnesses;
- vi. reviewing its decisions, directions and orders;
- vii. any other matter which may be prescribed.
- The State Commission shall have the powers to pass such interim order in any proceeding, hearing or matter before the State Commission, as that Commission may consider appropriate.
- The State Commission may authorise any person, as it deems fit, to represent the interest of the consumers in the proceedings before it.

1.4. Infrastructure of the Commission

- Office premises: The Commission operates from its leased premises of 10,000 square feet at 5th Floor, Singareni Bhavan, Red Hills, Hyderabad.
- Website: The Commission's website is (www.tserc.gov.in) which is regularly maintained and updated. The Commission's orders, public announcements, press releases, reports, RTI, clarifications, objections received and Regulations notified by the Commission are updated on the website on a regular basis. The Commission has also designed and developed a website for the Vidyut Ombudsman, Telangana (http://vidyutombudsman-tserc.gov.in/) wherein the orders, hearing schedules, the relevant Acts & Regulations, consumer grievances and details of the Consumer Grievance Redressal Forum are placed.

1.5. Staff of the Commission:

- The Commission to efficiently discharge its functions under the mandate of the Electricity Act 2003 comprises of staff with expertise and experience in engineering, economics, financial management, accounting, law, human resources, management information system and related skills.
- For functional convenience, the office of the Commission is organized into various departments such as Tariff, Law, Engineering, Human Resources and Accounts. Each department is headed by its functional expert, who renders his/her services to the Commission.

• The Commission, soon after its formation, has adopted all the regulations of erstwhile APERC vide regulation No. 1 of 2014. Accordingly, Regulation No 3 of 1999 and Regulation no 5 of 2013 of erstwhile APERC are applicable to the Officers and staff of the Commission. The Commission has forwarded a service regulation for Officers and Staff of the Commission to the Government of Telangana for its approval under section 91 (2) of Electricity Act, 2003. The Commission is yet to receive approval for the same. Pending receipt of the approval, the adopted regulations are in vogue.

- a) Commission conducted a meeting with TS DISCOMs on purchase of short term power through national e-portal and issued guide lines for implementing.
- b) TS GENCO has filed ARR for determination of tariff (Aggregate Revenue requirement for TS GENCO power station for the control period 2014-19. Commission has admitted the filings and allotted O.P.NO 26 of 2016

2.3. Major Decisions in 2016-17

Commission issued orders in OP No 11 of 2016 Dated 16-07-2016. The petition was filed for consent / approval to Solar PPAs of Solar Parks for the Power Purchase Agreement (PPA) entered by the Southern Power Distribution Company of Telangana Ltd. (TSSPDCL) with - (i) the Individual Generators in the Solar park developed by M/s.Enrich Energy Pvt. Ltd at Zaheerabad, Medak District of 60 MW on Long Term basis; (ii) M/s. Rays Power Infra Pvt. Ltd., for procurement of 2 MW on long term basis out of 10 MW Solar Park developed by it at Dharmajipet (v), Dubbak (m), Medak district.

- Commission issued orders in O. P. No. 18 of 2016 Dated 13.06.2016 in the matter of Suo-Moto Determination of Generic Tariff for energy generated from Municipal Solid Waste (MSW)and Refuse Derived Fuel (RDF) based power projects in the State of Telangana achieving CoD during the period from 13-06-2016 to 31-03-2019.
- Commission issued orders in O. P. No. 10 of 2016 Dated 30.07.2016 in the matter of according approval to the two Power Purchase Agreements(PPAs) i.e., one entered into between (i) NTPC Limited and Southern Power Distribution Company of Telangana State Limited (TSSPDCL) and the other one between NTPC Limited and Northern Power Distribution Company of Telangana State Limited (TSNPDCL) for sale of power from the Telangana Super Thermal Power Project (Phase I) (2x800 MW) being located in Ramagundam, in Karimnagar District, Telangana State.
- Commission issued a common order in the matter of deciding the JURISDICTION Dated 31.10.2016.
- Commission issued interim order in O.P.No.93 of 2015 Dated 31-03-2017 in the matter of consent to the Power Purchase Agreement (PPA) entered into by the Telangana State DISCOMs (TSDICOMs) with the Chhattisgarh State DISCOM (CSDISCOM) for purchase of 1000 MW of Power on Long Term basis, wherein, Southern Power Distribution Company of Telangana State Limited (TSSPDCL) being the Procurer-I & the Lead Procurer and Northern Power Distribution Company of Telangana State Limited (TSNPDCL) being the Procurer-II

Chapter 3 – Tariff Orders

3.1. Tariff filings

- 3.1.1.In accordance with the provisions of Section 64 of the Act, it is incumbent upon the Distribution Licensees to make an application to the Commission to determine the tariff in such manner and terms as may be specified by the Regulations framed by the Commission.
- 3.1.2.The Distribution Licensees have to file ARR and proposals for Retail Supply Tariff for the entire Control Period from FY 2014-15 to FY 2018-19. However, they sought permission from the Commission to file ARR for Retail Supply Business for FY 2017-18 on annual basis in view of the uncertainty of projection of energy availability and estimation of power purchase cost for the entire Control Period and Tariff. The Commission permitted filing of ARR for the Retail Supply Business (RSB) only for FY 2017-18 vide its Lr. No. TSERC/Tariff/DD(T-Engg)/T-03/2015D.No. 708/16 Dt.19.11.2016.
- 3.1.3.The Distribution Licensees were to file their ARR and Tariff proposals for FY 2017-18 on or before 30.11.2016, so as to make available to the Commission the statutory time of 120 days for determination of Tariff for FY 2017-18 commencing April 1, 2017. The Distribution Licensees filed only the ARR for FY 2017-18 on 30.11.2016 and sought additional time in multiple instalments for filing of tariff proposals citing certain reasons. Considering the requests of the DISCOMs, they have failed to file the tariff proposals and instead sought further time for filing the same vide the letters dated 15.01.2017 and 31.01.2017 seeking time up to 28.02.2017. The Commission vide its letter dated 17.02.2017 directed the DISCOMs to file the tariff proposals by 23.02.2017 and in default of the suo-motu proceedings for determination of retail supply tariff for FY 2017-18 would be initiated.
- 3.1.4.The DISCOMs vide the letters dated 23.02.2017 and 06.03.2017 further sought additional time for filing the tariff proposals for FY 2017-18 lastly up to 15.04.2017. The tariff proposals for FY 2017-18 have been filed by the DISCOMs on 13.04.2017. The DISCOMs submitted that while it had put in all the efforts for filing the tariff proposals on time, the delay in filing was

mainly attributable to the participation of Telangana State in UDAY and signing the MoU in this regard on 04.01.2017 and the initiative of Ministry of Power, GoI for examining and recommending the options for simplification and rationalisation of consumer categories and tariffs. Citing the above reasons, the DISCOMs requested the Commission to condone the delay in filing of tariff proposals for FY 2017-18. The DISCOMs in their tariff proposals for FY 2017-18

- 3.1.5.The Commission finds that although the DISCOMs have cited one of the reasons for delay as rationalisation of consumer categories and tariffs, nothing of that sort has been proposed in their tariff proposals for FY 2017-18. On the other reason of delay i.e. participation in UDAY, the DISCOMs have stated that the delay is on account of ascertaining the quantum of benefits under UDAY that could be passed on to the consumers.
- 3.1.6. The Commission expresses its extreme displeasure on the inordinate delay in filing the tariff proposals by the DISCOMs. The DISCOMs, in their tariff proposals, have not submitted any material information on the reasons cited for delay in its various correspondences with the Commission. The objective of the Electricity Act 2003 is to protect the interests of the consumers and the Licensees. Although the delay in filing the tariff proposals is not desirable, it is also not desirable to determine the tariffs without considering the benefit of participation in UDAY, which should be passed on to the consumers with immediate effect. Hence, the Commission finds it appropriate to condone the delay in filing of tariff proposals by the DISCOMs. We expect the DISCOMs to adhere to the terms and conditions agreed to in the UDAY MoU in respect of filing of ARR on time from next year without fail.

Chapter 5 – Consumer advocacy

5.1. Standards of Performance (SoP) of DISCOMS

- 5.1.1.TSERC (Licensees' Standards of Performance) Regulation, 2016 as amended from time to time contains provisions relating to (a) guaranteed SoP, being the minimum standards of service that a distribution licensee shall achieve to individual consumers; (b) overall service Standards which the licensee shall seek to achieve in the discharge of obligation as a Licensee; and (c) compensation payable and manner of payment of compensation to consumers for non- compliance of the Standards in terms of provisions of Section 57 of the Act, 2003
- 5.1.2.Consumer participation in Electricity Regulatory process is necessary and important to ensure transparency and accountability. The Act 2003 requires the Commission to consult consumers on important policy and regulatory matters before arriving at any decision.
- 5.1.3.Regulatory matters were brought in the public domain through publication of Public Notice in daily newspapers, issuing Press Releases and also by placing the matter on the website of the Commission seeking suggestions/comments from the interested persons and stakeholders.

5.2. Consumer Grievance Redressal Forum

5.2.1.Each Forum shall consist of four Members, including Chairperson of the Forum. The DISCOM concerned appoints the Chairperson and two Members of its Forum on full time basis and the Commission nominates one independent Member who is familiar with consumer affairs as mandated.

5.3. Vidyut Ombudsman

- 5.3.1. The Telangana State Electricity Regulatory Commission (TSERC) was constituted on 3rd November, 2014 after formation of the State of Telangana. By Regulation No. 1 of 2014 the previously subsisting Regulations, decisions, directions etc., were adopted.
- 5.3.2.A separate institution of Vidyut Ombudsman for the state of Telangana has been established under Sub Section (6) of Section 42 of the Electricity Act, 2003 on 11.02.2015. Sri R.Damodar, (Retd.) Secretary Law (Legal Affairs) was appointed

to discharge the functions of Vidyut Ombudsman for the state of Telangana and assumed charge on 11.02.2015.

- 5.3.3.The institution of Vidyut Ombudsman is an authority providing an effective, alternative, time-bound and cost-less route for resolving the problems of the Electricity Consumers. Any person affected by any deficiency in electricity related service can approach the Vidyut Ombudsman for redressal of grievances only by way of an appeal. Keeping in view the goal of speedy redressal of Appeals arising out of decisions of the Consumer Grievances Redressal Forums, the appeals are being disposed of with no expenses to the aggrieved parties, with the cost being borne by the Power Distribution Companies.
- 5.3.4. Any Complainant, if aggrieved by the non-redressal of the grievance by the Forum, may make a representation to the Vidyut Ombudsman within thirty (30) days from the date of the receipt of the decision of the Forum or from the date of the expiry of the period within which the Forum was required to take decision and communicate the same to the Complainant. However, the Vidyut Ombudsman may entertain an appeal after the expiry of the thirty (30) days period, if satisfied that there is sufficient cause for not filing it within that period.
- 5.3.5.The Vidyut Ombudsman shall decide the representation finally within three (3) months from the date of the receipt of the representation of the Complainant and in the event the representation is not decided within three months, the Vidyut Ombudsman shall record the reasons thereof, including the cost to be paid by the licensee in case the reasons for the delay is attributable to the licensee. In case the delay is for reasons attributable to the Complainant, the Vidyut Ombudsman may reject the representation. Further, the Vidyut Ombudsman may pass such interim orders as the Vidyut Ombudsman may consider appropriate pending the final decision on the representation.

Audit of Accounts:

The Comptroller & Auditor General of India have audited the financial statements of the Commission in accordance with section 104(2) of the Electricity Act, 2003. The Separate Audit Report containing the comments of the Comptroller & Auditor General India (CAG) the accounting of on treatment received vide letter No.PAG(Audit)/ES(Power)/TSERC/AA-16-17/2017-18/19 Dated 21.02.2018 is furnished hereunder.

SEPARATE AUDIT REPORT OF THE COMPTROLLER AND AUDITOR GENERAL OF INDIA ON THE ACCOUNTS OF TELANGANA STATE ELECTRICITY REGULATORY COMMISSION, HYDERABAD FOR THE YEAR ENDED 31ST MARCH, 2017

- We have audited the attached Balance Sheet of Telangana State Electricity Regulatory Commission (TSERC) as at 31st March, 2017 and the Income and Expenditure Account/Receipts and Payments Account for the period from 01.04.2016 to 31.03.2017 under section 19(2) of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 read with Section 104 (2) of the Electricity Act, 2003. These financial statements are the responsibility of the TSERC's management. Our responsibility is to express an opinion on these financial statements based on our audit.
- 2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards, disclosure norms, etc. Audit observations on financial transaction with regard to compliance with the Law, Rules and Regulations (Propriety and Regularity), efficiency-cum-performance aspects etc., if any, are reported through Inspection Reports/CAG's Audit Reports separately.
- 3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.
- 4. Based on the preliminary observations made by us, the accounts of the Commission have been revised. **Due to revision, the excess of Income over**

expenditure has been increased by Rs.6.17 lakh and total assets and liabilities of the balance sheet have also been increased by Rs.19.64 lakh.

- 5. Based on our audit, we report that:
 - i. We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit;
 - ii. The Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report have partially been drawn up in the format approved by the Committee of Experts formed by Central Government.
 - iii. In our opinion, proper books of accounts and other relevant records have been maintained by the TSERC as required under section 104 (1) of the Electricity Act, 2003 in so far as it appears from our examination of such books.
 - iv. We further report that:

Comments on Accounts:

Balance Sheet

Assets

Fixed Assets (Schedule -3) : Rs.60,31,704

 This includes an amount of Rs.3,99,314 in respect of assets pertaining to the Vidyut Ombudsman. As these assets do not belong to the TSERC, the same should not have been accounted for as the assets of the Commission. This resulted in overstatement of Fixed Assets and Capital Fund by Rs.3,99,314.

Liabilities

Current Liabilities and Provisions (schedule-2) - Rs.7,10,01,461 Gratuity on superannuation - Rs.60,79,335

 In the absence of actuarial valuation to ascertain the actual liability towards gratuity on superannuation, audit could not authenticate the veracity of the provision for liability – gratuity for superannuation accounted for by the Commission. Income and Expenditure Account: Expenditure Other Administrative expenses State Vidyut Ombudsman Expenditure

3. The TSERC received an amount of Rs.66,99,000 from the Licensees towards Vidyut Ombudsman (which is not part of TSERC) expenditure which is treated as income under schedule-7. Against this, an amount of Rs.55,31,878 was spent which was treated as Other administrative expenses under schedule – 11 during the year 2016-17. The treatment of income and expenditure relating to Vidyut Ombudsman through the Income and Expenditure Account of the TSERC has resulted in overstatement of Income over expenditure for the year by Rs.11,67,122. Consequently, the Capital fund was overstated by Rs.11,67,122. Though similar audit observation was commented in the previous year accounts, TSERC continued the same practice without proper justification.

(B) Grants-in-Aid:

Out of the grants-in-aid of Rs.5.38 crore received during the said period, TSERC utilized the entire amount leaving Nil balance as unutilized grant as on 31.03.2017.

- v. Subject to our observations in the preceding paragraph, we report that the Balance Sheet and Income and Expenditure/Receipts and Payments Account dealt with by this report are in agreement with the books of accounts.
- vi. In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Notes and subject to the significant matters stated above and other matters mentioned in the Annexure to this Separate Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India.

- b) In so far as it relates to the Income and Expenditure Account of the surplus for period from 01.04.2016 to 31.03.2017.

SCHEDULE-12 SIGNIFICANT ACCOUNTING POLICIES

- 1. As per the G.O. Ms. No.14, Dated 01.11.2014, the assets and liabilities of the erstwhile APERC were provisionally allocated between the TSERC and the APERC. From 03.11.2014 separate accounts have been maintained for the TSERC.
- 2. The accounts are prepared on accrual system except for stationery and other petty expenses.
- 3. The accounts are prepared based on the report of the expert committee on common format of Accounts for autonomous bodies.
- 4. The TSERC Fund Rules, 2015 have been issued vide G.O.Ms.No.15, Energy (Budget) Dept. Dt: 04.05.2015. All revenues of the Commission including the grants and loans by the Government, the fees and other sums received by the Commission were remitted to the Fund. All the expenditure of the Commission was met from the Fund.
- 6. The petition fee is recognized as revenue as and when the petitions received and accepted. License fee revenue is based on the energy handled by the distribution licensees and allocated capacity of the Transmission licensee during the year.
- 7. Depreciation on the assets of the Commission (excluding the furnishing articles provided at the residences of the Chairman and the Members of the Commission) is provided at the SLM rates specified in the Companies Act, 2013.
- 8. Depreciation on the Furnishing Articles supplied to the Chairman & Members of the Commission is provided at 50 percent on SLM in respect of articles falling under Annexure I and 15 percent on WDV method in respect of articles specified in Annexure II in line with High Court Judges (Writing off, selling and utilization of Furnishing Articles) Rules, 1990.
- 9. Pension fund has been created to meet the future pension liability of employees of the TSERC excluding the leave encashment and gratuity duly constituting the TSERC Employees Pension Trust.
- 10. Provision for EL encashment, gratuity and LSPC for the officers and staff provided to meet the future liability.
- 11. Advance received from DISCOMs towards VO budget shown as liability.
